

Transport of Prohibited and Dangerous Articles

Some articles may endanger the safety of an aircraft or even the persons that travel on it, so the transport of these articles is prohibited or restricted by regulations. The articles transported outside of the respective security conditions will be apprehended during the verification of your luggage. The presented following lists are subject to possible changes, proposed by the regulatory authorities.

Prohibited articles - Passengers and Cabin baggage

Guns, firearms and other devices that shoot projectiles

- Firearms of all types such as: pistols, revolvers, rifles and shotguns;
- Toy guns, replicas or imitations of firearms that may be mistaken for real guns;
- Components of firearms, excluding telescopic sights;
- Compressed air and CO2 guns, such as pistols, pellet guns, rifles and ball bearing guns;
- Signal flare pistols and starter pistols;
- Bows, cross bows and arrows;
- Harpoon guns and spear guns;
- Slingshots and catapults.

Disabling devices and electro shock weapons

- Devices for shocking, such as stun guns, Tasers, and stun batons;
- Animals stunners and animal killers;
- Disabling and incapacitating chemicals, gases and sprays, such as mace, pepper sprays, Capsicum sprays, tear gas, acid sprays, and animal repellent sprays.

Objects with a sharp point or sharp edge

- Items designed for chopping, such as axes, hatchets and cleavers;
- Ice axes and ice picks;
- Razor blades;
- Box cutters;
- Knives with blades of more than 6 cm (2.4 in);
- Scissors with blades of more than 6 cm (2.4 in) as measured from the fulcrum;
- Martial arts equipment with a sharp point or sharp edge;
- Swords and sabers.

Workmen's tools

- Crowbars;
- Drills and drills bits, including cordless portable power drills;
- Tools with a blade or a shaft of more than 6 cm (2.4 in) capable of use as a weapon, such as screwdrivers and chisels;
- Saws, including cordless portable power saws;
- Blowtorches;
- Bolt guns and nail guns.

Blunt instruments

- Baseball and softball bats;
- Clubs and batons, such as, blackjacks, Billy clubs, night sticks
- Martial arts equipment.

Explosives and incendiary substances and devices

- Ammunition;
- Blasting Caps;
- Detonators and fuses;
- Replica or imitation of explosive devices
- Mines, grenades and other military explosives;
- Fireworks and other pyrotechnics (devices);
- Smoke-generating canisters and smoke-generating cartridges;
- Dynamite, gunpowder and plastic explosives.

Liquids, aerosols and gels

The transport of liquids on board is only allowed in containers with capacity up to 100 ml and not more than a total of 1 liter per passenger. These articles should be packed in a transparent plastic bag with easy opening and closing system, with dimension of 19 cm x 20 cm.

Prohibited articles in checked baggage

Explosives and incendiary substances and devices

- Ammunition;
- Blasting Caps;
- Detonators and fuses;
- Replica or imitation of explosive devices;
- Mines, grenades and other military explosives;
- Fireworks and other pyrotechnics (devices);
- Smoke-generating canisters and smoke-generating cartridges;
- Dynamite, gunpowder and plastic explosives.

Baggage with installed lithium batteries

Non-removable batteries exceeding 0.3 g of lithium metal or 2.7 Wh.

Dangerous goods - Prohibited for transportation in cabin baggage and checked baggage SATA Azores Airlines

- Bags or folders with pyrotechnics devices and lithium batteries;
- Fuel for lighters;
- Paint strippers, bleaching agents, chlorines;
- Flammable liquids, such as fuel, ink, Diluent, solvent, acetones;
- Toxic, infective and radioactive materials;
- Chemical products, fertilizers, herbicides, pesticides;
- Ink, varnishes and lacquers;
- Gases;
- Life rafts, machines powered by fuel;
- Stoves and camping containers having contained flammable liquid fuel or flammable gases;
- Styrofoam boxes or other packages with cannot prevent accidental leakage for example, from fish, shellfish other products;
- Demijohn (large bottles) that are not properly packed;
- Mobile device Samsung Galaxy Note 7;
- Small locomotion vehicles powered by lithium batteries (e.g. Airwheel, solowheel, hoverboard, mini- segway, balance wheel, scooter and bicycles).
